

For returnees and entrants from India , Sri Lanka, Nepal, Pakistan, Bangladesh, Maldives, Afghanistan

• If you have stayed in the countries and regions listed above within the last 14 days, the following measures are required by quarantine of Japan.

① Submit inspection certificate

• At the time of entry, submit or present a certificate or a copy of certificate of preentry test issued within 72 hours prior to departure and certified as "negative" by the local medical institution to the quarantine officer.

2 Quarantine in the accommodation of the government

- You will be tested for Covid-19 at the airport and will be quarantined in the accommodation of the government.
- If you do not follow the instructions of the quarantine officer, you may be detained in accordance with the Quarantine Act.
- <u>On the third day, the sixth day and the tenth day</u> after your entry to the accommodation (the date of entry into Japan is not included), you will be tested again. If the result is negative, you will leave the accommodation.
- After leaving the accommodation, you must remain at home, etc. for 14 days after entering Japan.

3 Submit written pledge

- You will need to submit a written pledge to remain at home, etc. for 14 days after arrival, not to use public transportation, to report your health conditions using the e-mail, etc., to store your location information using a map application function, send your location information to Health Monitoring Center for Overseas Entrants upon their request, to use Covid-19 Contact-Confirming Application, etc.
- If you violate the pledge, your name (name and nationality if you are non-Japanese) and information that contributes to the prevention of the spread of infection may be publicized.
- In addition to the above if you are a non- Japanese, you may be subject to revocation of status of residence and deportation etc. under the provisions of the Immigration Control and Refugee Recognition Act in case of the violation.

% For returnees and entrants from Afghanistan, the above measures will apply from June 4th , 2021 , 0:00am (Japan Time).



For returnees and entrants from Vietnam, Malaysia

- If you have stayed in the countries and regions listed above within the last 14 days, the following measures are required by quarantine of Japan.
- ① Submit inspection certificate
- At the time of entry, submit or present a certificate or a copy of certificate of preentry test issued within 72 hours prior to departure and certified as "negative" by the local medical institution to the quarantine officer.
- 2 Quarantine in the accommodation of the government
 - You will be tested for Covid-19 at the airport and will be quarantined in the accommodation of the government.
 - If you do not follow the instructions of the quarantine officer, you may be detained in accordance with the Quarantine Act.
 - <u>On the third day and the sixth day</u> after your entry to the accommodation (the date of entry into Japan is not included), you will be tested again. If the result is negative, you will leave the accommodation.
 - After leaving the accommodation, you must remain at home, etc. for 14 days after entering Japan.
- 3 Submit written pledge
 - You will need to submit a written pledge to remain at home, etc. for 14 days after arrival, not to use public transportation, to report your health conditions using the e-mail, etc., to store your location information using a map application function, send your location information to Health Monitoring Center for Overseas Entrants upon their request, to use Covid-19 Contact-Confirming Application, etc.
 - If you violate the pledge, your name (name and nationality if you are non-Japanese) and information that contributes to the prevention of the spread of infection may be publicized.
 - In addition to the above if you are a non- Japanese, you may be subject to revocation of status of residence and deportation etc. under the provisions of the Immigration Control and Refugee Recognition Act in case of the violation.

Target States in the USA

- All persons returning to or entering Japan from abroad (except the countries and regions listed above), the following measures are required by quarantine of Japan.
- ① <u>Submit inspection certificate</u>
 - At the time of entry, submit or present a certificate or a copy of certificate of preentry test issued within 72 hours prior to departure and certified as "negative" by the local medical institution to the quarantine officer.
- 2 Test at the airport
 - You will be tested for Covid-19 at the airport .If the result is negative, you have to remain at home, etc. and do not have to use public transportation for 14 days after entering Japan.

③ Submit written pledge

- You will need to submit a written pledge to remain at home, etc. for 14 days after arrival, not to use public transportation, to report your health conditions using the e-mail, etc., to store your location information using a map application function, send your location information to Health Monitoring Center for Overseas Entrants upon their request, to use Covid-19 Contact-Confirming Application, etc.
- If you violate the pledge, your name (name and nationality if your are non-Japanese) and information that contributes to the prevention of the spread of infection may be publicized.
- In addition to the above if you are a non- Japanese, you may be subject to revocation of status of residence and deportation etc. under the provisions of the Immigration Control and Refugee Recognition Act in case of the violation.
